The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Colonial Life & Accident Insurance Company, Health Advocate Solutions, Inc., Humana Insurance Company, The Lincoln National Life Insurance Company, Pre-Paid Legal Services Inc dba Legalshield and UnitedHealthcare Insurance Company to pay Health, Dental, Vision, Life Insurance, Accidental Death and Dismemberment, Short-Term Disability, Long-Term Disability, Voluntary Benefits, Long Term Care, Employee Assistance Program and Legal Services Plan Memberships claims incurred under the terms of the plan. The total premiums paid for the plan year ending December 31, 2025 were \$2,757,354.
